#### 7. TO CONSIDER NEWSLETTER PRODUCTION

The Clerk reported that all research points towards growing a social media presence and maintaining a good website. It was reported from Andy Joliffee from East Suffolk Council that some other parishes have decided to move forward and have no newsletter and others now just contribute an article or two to other publications. The Clerk reported that the true annual cost of the Newsletter sits at approximately £7,000 Mr J Wright suggested that the Parish Council focus its efforts on a more online based reporting system instead of the traditional paper copies of the Newsletter. Parish Council News should be more instantly available following on from national trends. Mr R Whiting suggested that no Summer Newsletter should be produced with further discussions in mind regarding a winter addition.

Mr J Wright proposed that focus on Social Media Platforms and the Parish Council Website should be a priority over the summer instead of the newsletter with the item reviewed for the winter. Seconded by Mr M Newton. Resolved with ALL in favour.
